THE EMBU COUNTY FINANCE BILL, 2016

A Bill for

AN ACT of the Embu County Assembly to provide for various taxation, imposition of fees and charges for services, and other revenue raising measures by the County Government; and for matters incidental thereto

ENACTED by the County Assembly of Embu as follows—

PART I – PRELIMINARY

1. This Act may be cited as the Embu County Finance Act, 2015 and shall come into operation upon publication in the *Gazette*.

Short title and Commencement

2. Unless the context otherwise provides, the following terms shall have the meaning assigned to them—

Interpretation

“business” includes—

- (a) any activity in the nature of trade, commerce or manufacture, profession, vocation or occupation referred to in the first schedule ; and
- (b) any activity carried on by a person continuously or regularly whether or not for gain or profit and which involves, in part or whole, the supply of goods and services.

“Calendar year” means a period of twelve months commencing 1st of January each year;

“CBD” Means the central business district of Embu town with the exception of the estates known as Majimbo, Dallas, Majengo, Blue Valley, Kanjuru and Kangaru.

“Executive Committee Member” means the County Executive Member responsible for finance ;

“Cess” means tax or fees chargeable on goods under the second Schedule of this Act;

“County Government” means the County Government of Embu;

“County Public Officer” means a county public officer within the meaning of section 2 of the County Governments Act, of 2012;

“County Receiver of Revenue” means; the persons appointed pursuant to section 157 of the Public Finance Management Act, 2012;

“County Revenue Collector” means the county public officer appointed pursuant to section 158 of the Public Finance Management Act, 2012 for the purpose of collecting revenue for the County Government and remitting it to the County Receiver of Revenue;

“fee” means any county tax, levy or other charge constituting county revenue.

“Khat Bundle” means a measure of khat not exceeding five kilogram’s;

“penalty” means such punishment in financial terms being the consequence of noncompliance with applicable financial obligations under this Act;

“person” includes a natural or juristic person;

“revenue fund account” means the bank account designated by the county executive committee into which local revenue as defined by the Public Finance Management Act is credited;

“revenue officer” means any person engaged by the county Government on whatever terms for purposes of collecting county revenue;

“Sub urban” means the immediate environs of the CBD including but not limited to Majimbo, Dallas, Majengo, Blue Valley, Kanjuru, Kangaru.

3. (1) All directions, resolutions, orders and authorizations on or relating to financial management, including the collection and administration of taxes, fees and charges given or issued by the defunct Municipal and County Councils of Embu County and subsisting or valid immediately before the cessation of the application in the Local Government Act, Cap. 265 of Laws of Kenya (now repealed) shall be deemed to have been given, issued or made by or under the authority of the County Assembly until expiry, amendments or repeal of this directions, resolution, orders, authorization on financial management shall continue with the necessary modification, apply both to the payment and administrating of the taxes, fees,

charges and other levies under this Act.

(2) All directions, resolutions, orders, authorizations and provisions that are contained in Any County Revenue Act, County Rating Act, County Revenue Administration Act, County Tax Waiver Administration Act, Embu County Trade License Act, Public Financial Management Act, 2012 and other related laws and subsidiary legislations that are concerned with revenue administration in the county shall be deemed to be part of this Act.

PART II—TAXES, FEES AND CHARGES PAYABLE AND RATES APPLICABLE

4. Annual fees shall be valid for a calendar year

Annual Fees

5. Despite the generality of clause 4 —

Fees due and payable

- (a) fees and penalties that remain outstanding at the commencement of this Act shall remain due and payable
- (b) annual licenses and permits shall lapse on the 31st December in each year provided businesses commencing after June shall attract fifty per cent of the annual permit fees.
- (c) a penalty of 10% of the applicable annual fees shall apply for every month in which the fees remain unpaid after 31st of March in each year.
- (d) to the County Revenue Account.
- (e) annual licenses and permits shall lapse on the 31st December in each year provided businesses commencing after June shall attract fifty per cent of the annual permit fees.
- (f) a penalty of 10% of the applicable annual fees shall apply for every month in which the fees remain unpaid after 31st of March in each year.
- (g) charges shall be collected per Sub County. Fees charged in one Sub County shall be for conducting business in that sub-county only.

6. It is the duty of a person from whom any fees is chargeable to ensure that such fees are paid, whether or not a demand has been made.

Duty to pay fees

7. For the avoidance of doubt as to the applicable fees

Categorization of Commercial Centers

within the County, the various commercial centres and their environs shall be zoned into the various categories as indicated in the tenth schedule of this Act.

8. (1) A person shall not carry out any business or service within the County without a valid licence or permit issued by the relevant County office.

Business Licences or
Permits

(2) A person who intends to carry out any of the businesses listed in the or under the schedule or the single business permit regulation shall apply for a licence or permit from any of the County offices or such other designated agents as shall be prescribed by the County Government from time to time.

(3) A person who applies for licence under subsection (2) shall be issued with a licence on the payment of the applicable fee as specified in the third, fourth, fifth, sixth and seventh columns in respect of the business activities defined in the first and second columns of the first schedule depending on the location and size of the business as specified in the schedules of the single business permit Fees and Charges.

(4) Licences and permits issued under subsection (3) must be visibly displayed at the business premise at all times.

(5) A person who contravenes any of the provisions of this section commits an offence.

9 (1) A person occupying any plot, stall or house leased or rented out by the County Government shall pay rent or rates in advance, whichever is applicable, at the rate specified in the Second Schedule to this Act.

Rent and Rates

(2) A penalty of two per centum per month shall be charged for any outstanding amount of ground rent or rates for a plot that remains unpaid for after the last working day of that month for rent and the last day of February each year for land rates.

(3) A person who contravenes the provisions of Sub sections (1) may be evicted and shall be evicted if he or she fails to pay house rent for two consecutive months.

(4) The County Government may repossess the plot if a person fails to pay the ground rent for more than one year

and five years for land rates.

10. (1) A cess or market fee shall be charged on the goods specified in the Schedules to this Act before entry for market fees and on demand for Cess.

Cess or market fee

(2) A person who fails or hinders other person to pay the cess or market fee set under schedule commits an offence.

11. Notwithstanding the generality of Clause 10—

Periodic charges

- (a) daily and market day charges become due and payable at the commencement of business for that day.
- (b) tonnage based charges shall be for each trip made
- (c) an additional fifty shillings per tonne will be charged as additional fee for night cess. Night charges apply from (8pm to 6am).
- (d) periodic rates and charges shall lapse at the expiry of the number of days constituting the period referred to an activity for which the prior approval of the County Government is a requirement shall not commence until such approval is obtained

12. (1) All person operating single business permits shall be required to pay for other relevant licenses, fees and charges as prescribed in the single business permit or by the nature of trade.

Other licences, fees and charges

(2) Any person operating a business who fails to pay the said fees, charges or licenses set under schedule and the single business permit regulations commits an offence.

13. Despite Section 11, the Executive Committee Member may, with the approval of the County Executive Committee, provide for special permits for multiple businesses within the same premises.

Special Permits

14. The various market rates and charges are specified in the third, fourth and fifth columns in respect of commodities and services specified in the first column of the second schedule.

Fees in respect of market rates

15. The Executive Committee Member shall, with the approval of the County Executive Committee, prescribe the

Fees for activities not contained in the schedules

applicable fees for any activity for which the applicable fees is not provided for in the first and second schedules.

16. (1) The County Executive Committee Member may by written notice—

Appointment of an agent

(a) appoint any person to be an agent of the County Government for the purposes of the collection or recovery of charges, permit fees, licence fees, rent, cess and such other fees, as may be necessary for carrying out the purposes of this Act; and

(b) specify the amount of charges, permit fees, licence fees, rent, cess and such other fees to be collected or recovered by the agent.

(2) An agent appointed under this section shall enforce and ensure due compliance with the provisions of this Act and shall remit all revenue collected to the County Government through the County Receiver of Revenue or as may be otherwise instructed in the appointment notice.

(3) Where an agent claims to be, or to have become unable to comply with subsection (2), such shall, within seven working days, notify the Executive Committee Member in writing, setting out fully the reasons for his inability to comply, and the Executive Committee Member shall accept the notification and cancel or amend the appointment notice accordingly.

(4) Unless and until a notification is given by an agent under subsection (3), sufficient moneys for the payment of charges, permit fees, licence fees, rent, cess and such other fees specified in the agent's appointment notice shall be presumed to be held by him and this money shall be due and payable to the County Government.

(5) For the purposes of this section, the Executive Committee Member may, by notice in writing, at any time, require any person to furnish him or her, within reasonable time not being more than seven days from the date of service of the notice, with information showing any moneys which may be held by the agent for, or due by him to the County Government

(6) Where an agent fails to pay an amount of money collected under this section within the time specified in the notice, the provisions of this Bill relating to the collection

and recovery of tax shall apply to the collection and recovery of that amount as if it were tax due and payable by the agent, the due date for the payment of which was the date upon which that amount should have been paid to the County Government under this subsection.

(7) An agent who makes a payment to the County Government under this section shall for all purposes be deemed to have acted under the authority of the County Government and shall be indemnified in respect of that payment against all proceedings, civil or criminal, and all processes, judicial or extra-judicial, notwithstanding any provisions to the contrary in any written law, contract or agreement.

(8) Any person who wilfully makes any false or misleading statement, or wilfully conceals any material fact shall be guilty of an offence.

17. A person or entity that defaults on payment of any fees shall have committed an offence punishable—

Penalties for defaulters

- (a) in the case of single business permits, by a fine prescribed by a court not exceeding One hundred thousand in addition to the payment or Six months imprisonment or both notwithstanding interest accrued on late payments.
- (b) in the case of market charges, by impounding of commodities and holding the same in safe custody until fees and impounding charges are paid.

All goods will be impounded at owner’s risk. For perishable goods they must be collected before close of business the next day after the impounding day. Livestock impounded must be collected within two working days. For any other goods and tools they must be collected within fourteen days. The County will dispose off all goods and livestock after the prescribed period expires in a manner it deems fit;

- (c) in the case of advertisements, promotions and any outdoor publicity, by a fine equal to three times the applicable fees.;

- (d) in the case of all fees related to buildings and constructions approvals, by a fine equal to three times the applicable fees.

18. All revenue shall be paid into the County revenue fund account. An officer who fails to remit such funds commits an offence.

Revenue to be paid into county revenue fund account

19. (1) The Executive Committee Member for finance shall take measures to recover any revenue that is not paid into the county revenue fund account by the Revenue Officer or Revenue collector.

Failure to pay revenue into County Revenue Account

(2) A revenue officer who fails to pay revenue into the county revenue account commits an offence punishable in accordance with the provisions of Section 199 of the PFM Act, 2012.

20. (1) There is established a County directorate of enforcement services whose mandate shall include enforcing compliance with the various revenue measures specified in this Act.

Establishment of Directorate of enforcement services

(2) The directorate shall be headed by a director, who shall be competitively recruited by the County Public Service Board and appointed by the Executive Committee Member for Finance with the approval of the County Assembly.

(3) Despite subsection (2), the director of enforcement services shall serve for a term of four years and shall be eligible for reappointment for a further one term.

(4) The County Public Service Board shall in consultation with the director of enforcement services establish and equip the directorate established under subsection(1).

(5) The officers of the directorate shall be recognizable by the Kenya police service and shall have powers to arrest offenders under any County law.

21. (1) The Composition of the directory shall consist of is as follows;

- (c) Assistant Director,

- (d) Senior Inspector,
 - (e) Inspector,
 - (f) Sergeant / Senior Sergeant,
 - (g) Corporals
 - (h) Enforcement Officers
- (2) Functions of Directorate of Enforcement (DE)—
- (a) To enforce Embu County Finance Act and prevent loss of revenue
 - (b) To collect and develop intelligence relating to violation of the provisions of the Finance Act
 - (c) To conduct searches of suspected persons, conveyances and premises and seize incriminating materials and exhibits for prosecution
 - (d) To enquire into and investigate violation of provisions of the acts of the County Government
 - (e) To adjudicate cases of violation of the Finance Act and other County registrations
 - (f) To realise that penalties imposed in departmental adjudication;
 - (g) To attach and confiscate properties involved in the acts of tax evasion
 - (h) To arrest persons suspected to be involved in acts of revenue evasion
 - (i) Detect cases of violation and also perform substantive adjudicatory functions to curb such malpractices;
 - (j) To charge persons involved in acts of tax evasion;
 - (k) To collect and develop intelligence relating to violation of the provisions of Embu County Government Finance Acts and any other County Government registration, and while working out the same , depending upon the circumstances of the case, enquire into and investigate suspected violations

- (l) Ensuring compliance with revenue collection provisions
- (m) Escort Cash in Transit;
- (n) Ensure security of assets;
- (o) Disaster Management.
- (p) V.I.P protection
- (q) Keep surveillance over suspects,
- (r) Search of persons / Vehicles as per provisions of the Revenue Administration Act
- (s) Search of premises as per provisions of the Revenue Administration Act;

Any other functions as directed by the County secretary;

PART III—MISCELLANEOUS PROVISIONS

22. Any person who commits an offence under this Act for which no penalty is provided shall be liable, on Conviction, to a fine not exceeding two hundred thousand shillings for an individual or to imprisonment for a term not exceeding two years or both and one million shillings for a body corporate .

Offences and
General Penalty

23. The County Executive Member in consultation with the Executive Committee may pursuant to this Act make any further regulations for the administration of this Act including but not limited to regulations relating to-

Power to make
regulations

- (a) Appointing market days in respect of various market centres;
- (b) Establishing management structures for County markets; and
- (c) Composition and functions of the directorate.
- (d) Designated pick and drop areas.
- (e) Bus parks and parking areas.
- (f) Cess and cess collection points.

24. (1) The County Executive Committee Member may by order published in the gazette amend any additional fees, tax, license, cess and fees schedules to supplement the

current schedule.

(2) Any order made under subsection (1) shall be approved by the County Executive Committee and shall be without prejudice to anything previously done there under.

25. (1) Any charges, permit fees, licence fees, rent, rates, cess and such other fees payable to the County Government at the commencement of this Act by any business operating within the county which are not included in any of the Schedules to this Act, shall continue to be chargeable by, and payable to the County Government unless they are repealed by an Act of the County Government or until an Act of the County Government on such charges, permit fees, licence fees, rent, cess and such other fees is enacted.

Transitional
Provisions

(2) All business within the jurisdiction of the county shall be required to pay licenses, charges, fees, cess, rent or other prescribed fees unless specifically exempted by any relevant legislation or authority.

(3) All levies, charges, tax, cess, fees and licenses that were payable under the repealed Local Government Act, and are not provided for in this Act shall continue to be paid and administered under this Act: provided that this sub-section shall also apply to such fees and charges levied by various ministries and departments of the national government in respect of functions devolved to the county governments under part 2 of the Fourth Schedule of the Constitution of Kenya which fees and charges shall be levied by the County Government on transfer of the devolved functions.

(4) All references to Councils shall include all Local Authorities as were defined under the now repealed Local Government Act, Cap. 265 of the laws of Kenya.

MEMORANDUM OF OBJECTS AND REASONS

The Bill is intended to provide for various taxation mechanisms, imposition of fees and charges for services, and other revenue raising measures by the County Government; and for matters incidental thereto. It has two parts and ten schedules.

Part I—Preliminary (1-3)—The part contains the short title, interpretation and application of resolutions, directions under the repealed Local Government Act.

Part II—Taxes, Fees and Charges Payable and Rates Applicable (4-21)— The part defines various taxes that can be imposed by the County Government, fees and charges payable for various goods and services. It provides for rent and rates applicable, duty to pay allocated fee, categorization of commercial centers with different rates applicable.

The rent and rates payable includes those of plots, stalls or house leased or rented out by the county government.

It also introduces Cess or market fee on goods before entering the market. There are also the periodic charges especially the ones, which become due daily and on market days.

The Bill provides for payment for other licensee fees and charges prescribed in the single business permit The Bill also presupposes powers to the Executive Committee Member responsible for finance to appoint an agent to collect or recover charges, permit fees, licensee revenue collected is paint into.

To ensure compliance of the Act, the Bill establishes a Directorate outlining the composition and functions of the same.

Part III—miscellaneous Provisions (22-25)— In ensuring no one gets scot free for breaching any provisions of the Act whose penalty is not prescribed, the Bill provides for general offence and penalty. It also gives the Executive Committee member for Finance to make regulations and amend schedules by an order wherever there is need. Finally, the Bill provides for transitional provisions, which continues to apply when the Bill is enacted into an Act.

Enactment of this Bill may occasion additional expenditure of Public funds.
