1.0. BACKGROUND

In vetting nominees to the positions of the County chief officers under the portfolio on Education, Youth and Sports the Committee was guided by section 8(2) of the Embu County Public Appointment (County Assembly Approval) Act, 2015 and Section 45 of County Government Act, 2012, among other applicable legal framework.

Pursuant to Section 45 of the County Governments Act, 2012, the names of the nominees for the County Chief Officers including the names of Mr. Jerevasio Mbogo Muchungu for Education and Mr. Samuel Wachira Njue for Youth and Sports were among the names submitted to the County Assembly on 27th November, 2017 for vetting and approval. The names of the nominees were tabled on 29th December, 2017 and subsequently committed to the committee on Education, Youth and sports for consideration.

The committee pursuant to various Sections of the Embu County Public Appointment (County Assembly Approval) Act, 2015, conducted the vetting and approval exercises on, 7th and 8th December, 2017 in the Embu County- Ghyanshyam plaza, and retreated to compile this report for consideration by the Assembly.

1.0.1. Mandate Of the Committee

The Committee on Education, Youth and Sports has made this report pursuant to Standing Order No. 204 (5) of the County Assembly of Embu which defines among the functions of the committee as being;

- (a) To investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the department;
- (b) To study the program and policy objectives the department and the effectiveness of the implementation.

2.0.

COMMITTEE FINDINGS AND OBSERVATIONS

2.1 GUIDING LEGAL FRAMEWORK

(a) Embu County Public Appointment (County Assembly Approval) Act, 2015

In the vetting and approval process the committee was guided the Section 8 of the Embu County Public Appointment (County Assembly Approval) Act, 2015 which provides that:-

(1) Upon receipt of notification of nomination, the Clerk shall cause a notification to be made to the Assembly upon which it shall stand committed to the relevant Sectoral Committee.

(2) Upon receipt of a notification under subsection (1) the committee shall determine the time and place for the holding of the approval hearing.

(3) The Clerk shall notify a candidate of the time and place for the holding of an approval hearing and the committee shall-

(a) Notify the public of the time and place for holding an approval hearing at least seven days prior to the hearing; and

(b) Make the notice referred to under subsection (3)(a) above using modalities applicable under section 91 of the County Governments Act, 2012.

(4) The committee shall vet the respective candidate by way of scrutinizing the information provided by the appointing Authority and holding an approval hearing in accordance with this Act and the County Assembly Standing Orders.

(5) An approval hearing shall focus on a candidate's academic credentials, professional training and experience, personal integrity and background and any other matter that the committee may deem relevant.

(2) Other Legal Framework

The committee was also guided by the following legal framework:

- ✓ Section 45 an of the County Government Act, 2012
- ✓ Standing order No. 2014 (5) (f) of the County Assembly of Embu standing Order.
- ✓ Section 149 of Public Finance Management Act, 2012
- ✓ Section 22 of the Public Finance Management (County Governments) Regulations, 2015

2.2 CRITERIA FOR VETTING AND APPROVAL FOR MR. JEREVASIO MBOGO MUCHUNGU NOMINEE FOR COUNTY CHIEF OFFICER-EDUCATION.

Based the above legal framework the committee relied on the following criteria on vetting and approval of the nominee

1. Completion of the questionnaire.

It was observed the nominee had fully filled the questionnaire. However it was noted that the nominee had not made full disclosure for the following questionnaire items;16, 21(b),22, 24 and 26.(See Annexure I A). The nominee was requested to make full disclosures for the specific items.

2. A minimum of a degree from a recognized university

It was observed that the nominee had a Bachelor Degree in Education and a Master degree in Educational Administration. (See Annexure II A)

3.Understanding of the position to which the candidate is proposed for appointment

From the submissions the candidates understood the position he was nominated for.

4.Experience relevant to the position five years experience in administration

The candidate had the relevant experience(See Annexure III A)

5.Clearance from Ethics and Anti-Corruption Commission (EACC), Higher Education Loans Board (HELB), Kenya Police Service (Certificate of Good Conduct),and Kenya Revenue Authority (KRA)

All the above clearances were submitted and were well updated. The nominee had been fully cleared(See Annexure IV A)

6.Willingness to work for the prescribed remuneration

The nominee was ready to work for the prescribed remuneration.

7.Knowledge of government management systems related to being a County Secretary

From the submissions the nominee partially understood the government management system.

8. Understanding of relationship with County Executive Committee

From the submissions the nominee partially understood the above relationship.

9. Response to any matters raised by the Members of the County Assembly

The nominee responded well to all the issues raised by the committee regarding the questionnaire items where full disclosures had not been done and other matters raised by members of the committee incidental to the position of the chief officer
